About

Dr. Kenneth R. Conner, PsyD, MPH

Kenneth Conner is an Investigator at the Canandaigua (Upstate New York) VA Center of Excellence and an Associate Professor at the University of Rochester Medical Center where he is Co-Director of the Center for the Study and Prevention of Suicide. He has presented and published his research on substance abuse and suicide widely and is a past recipient of a national research award from the American Association of Suicidology. Dr. Conner chaired the national SAMHSA committee that produced Treatment Improvement Protocol ("TIP") 50, a 153 page publication by the U.S. Department of Health and Human Services. He also authored the accompanying training video produced by the Veterans Administration that will serve as the basis for the training in Cincinnati and Northern Kentucky.

PURPOSE

The purpose of the training is to teach suicide risk management with substance abuse clients, including risk factors, warning signs, protective factors, and a four-step process for managing suicide risk known as GATE that is spelled out in TIP 50 and illustrated through a series of video vignettes. Each attendee will receive a copy of TIP 50. There will be a significant emphasis on the role of agency administrators and clinical leaders in creating policies and protocols that support effective treatment of clients with substance abuse issues who are suicidal.

TARGET AUDIENCE

Substance abuse counselors, supervisors and program administrators, mental health providers across professional disciplines, case managers, employee assistance personnel, administrators, and other interested parties.

EXPECTED OUTCOMES/OBJECTIVES

As a result of this training, participants will be able to: (1) identify a four-step procedure for suicide risk management with substance abuse clients, (2) understand the difference between warning signs, risk factors, and protective factors for suicide and be able to recognize examples of each, and (3) recognize when to use regular supervision vs. immediate supervision in suicide prevention.
